**ANC 3C Resolution 2026-CONSENT**  
**Regarding the 2026 Rock 'N' Roll DC Half Marathon and 5K**

WHEREAS Advisory Neighborhood Commission 3C ("ANC3C") represents the residents of Woodley Park, Cleveland Park, Massachusetts Avenue Heights, and Woodland-Normanstone in Ward 3; and

WHEREAS the Ironman, Inc. filed an application with the Mayor's Special Events Task Group Division for the 2026 Rock 'N' Roll Half Marathon Series - slated for Saturday March 21, 2026;

WHEREAS the mission of the Mayor's Special Events Task Group Division is to provide outstanding support of the city's public safety planning efforts for events requiring interagency coordination and to provide the highest quality interagency reviews and assessments of the operational, public safety and logistical components of proposals for special events;

WHEREAS the 2026 Rock 'N' Roll Half Marathon Series is expected to have 19,500 participants - 16,000 half marathoners, 3000 5k participants, plus additional spectators;

WHEREAS the 2026 Rock 'N' Roll Half Marathon Series "turn by turn" route includes two blocks within Woodley Park, hence - streets within ANC3C are impacted as follows:

- Runners enter Woodley Park via Rock Creek Park at Calvert and 24th Street(s), NW
- Runners turn East onto Calvert Street, NW towards Connecticut Avenue, NW
- Runners cross Connecticut Avenue, NW towards the Duke Ellington Bridge
- Runners pass Woodley Place, NW onto the Duke Ellington Bridge towards Adam Morgan

WHEREAS the 2026 Rock 'N' Roll Half Marathon Series historically has little to no impact in Woodley Park.

THEREFORE, BE IT RESOLVED that ANC3C has no objection with the 2026 Rock 'N' Roll Half Marathon Series and supports the two-block route through Woodley Park: and

BE IT FURTHER RESOLVED that the Chair, Commissioner for 3C01, Commissioner for 3C02, Commissioner for 3C07, and/or their designee(s) are authorized to represent ANC3C on this matter.
